PURPOSE

By this information notice, ARISE IIP informs the companies qualified in the field of the development & construction of large scale Solar Power plants and power storage systems, that it is launching a call for tenders for the award of the development of a solar power plant including the provision of Battery Energy Storage System (BESS) located in Togo under:

- Option 1: an EPC contract along with Operation & Maintenance for 5 Yrs.
- Option 2: To form a Joint Venture between interested & eligible company and Arise IIP to supply power under 20 years PPA

These works are mainly for the long term reliable & sustainable power to Industrial Platform of Adetikope (PIA) and industries operating within PIA. The installed capacity of the various components of the project are the following:

- PV Plant (DC): 390 MWp
- BESS System: 200 MW
- Sub-station: 161 Kva

NAME OF THE PROJECT

Development of a solar power plant including power storage solution and 161 Kva grid connectivity.

Under Option 1 The project will be financed by ARISE IIP based on the selected option of development as defined in the section « Purpose » above.
