

## **International Call for Tender No. AOI 008/2021/NFM III-HIV/UGP**

*Reprography of data collection tools for the different interventions of the PNLIS-IST (fixed and mobile tools) including ANC/Accouchement/CPoN/PTME/PF*

1. The Project Management Unit (PMU) of the Global Fund to Fight AIDS, Tuberculosis and Malaria has obtained funding to finance the implementation of prevention services and quality of care in the fight against the HIV and TB epidemics (NFM III), and intends to use part of these funds for the reprography of data collection tools for the various NACP-STI interventions (fixed and mobile tools) including ANC/Accouchement/CPoN/PTME/PF. 3000 of each (registers, individual notebook, pink card) as part of HIV/SRH integration for 917 MNCH sites. Supplies must be delivered within one (1) month of receipt of the approved contract service order for each tranche.

**Note:** The contract will be awarded in a lump sum and payable in three instalments (2021, 2022, 2023) upon proof of service for each instalment. The firm tranche is payable from the 2021 budget and the conditional tranche from the 2022 and 2023 budgets. A service order will be sent to the contractor for the delivery of each tranche.

2. The Global Fund's Project Management Unit (PMU) is soliciting closed bids from eligible and qualified applicants for the delivery of said supplies in a single, indivisible package as described in Section V "Technical Specifications.

3. The procurement will be conducted by international competitive bidding as defined in the PMU's Administrative, Financial and Accounting Procedures Manual and will be open to the public.

procedures manual and open to all eligible candidates.

4. 5. Qualification requirements are:

- The company's legal requirements;
- The firm's financial requirements;
- The technical capability of the firm.

See the Bid Data Sheet for detailed information. However, the administrative documents required in clause IC 11.1 of the Bid Data Sheet are not eliminatory at the preliminary examination; but they are for the lowest evaluated bidder meeting the qualification criteria in the event that it has not provided them. In this case, the evaluation committee will ask the applicant to provide the said documents as additional information before awarding the

contract or eliminating it. On the other hand, the qualification documents required in clause IC 5.1 of the special data, including the bid guarantee, are eliminatory.

NB: "Newly formed companies that are unable to provide the required financial statements for the last three (3) years (2018, 2019 and 2020) are allowed to prove their economic and financial capacity by any other substitute document separate from the financial capacity certificate.

6. Interested candidates may consult the complete tender documents free of charge or withdraw them free of charge on a CD ROM provided by themselves or by e-mail at the address mentioned in point 4 above. Or download it from the PMU website [www.ugptogo.org](http://www.ugptogo.org).

7. Tenders must be submitted to the address mentioned in point 4 above no later than **December 7, 2021** at 10:00 am. Late bids will not be accepted.

8. Tenders must include a bank bid guarantee in the amount of three million six hundred and two thousand (3 602 000) CFA francs (about \$6,484).

9. Applicants will remain bound by their offer for a period of 120 days from the deadline for submission of offers.
