- ✓ Have not been in default in the execution of a previous contract with the CHU-Campus.
- ✓ Attach a certificate issued by a bank specifying an amount of credit facility equivalent to at least 0.5 times the financial offer,
- ✓ Present the turnover of the last three (03) years (2018, 2019, 2020) the average of which must be greater than or equal to half of the tender. Tenderers must also provide the financial statements of those years, certified by a chartered accountant or an accountant approved by the competent authority of the country.
